3 AUTHORIZING THE CITY ADMINISTRATOR TO RETROACTIVELY, "ACCEPT
4 AND EXPEND" A GRANT IN THE AMOUNT OF FIFTY THOUSAND DOLLARS
5 (\$50,000) FROM THE CALIFORNIA INTEGRATED WASTE MANAGEMENT
6 BOARD FOR THE PURPOSE OF IMPLEMENTING THE MODEL SCHOOL
7 PROGRAM.

10 WHEREAS, The San Francisco Recycling Program will implement a
11 model school program with the assistance of IWMB funding in the amount
12 of \$50,000.

13 Schools generate a virtually untapped source of organic and other
14 materials that can be recycled. These institutions engage in procurement,
15 materials, and waste management practices that are prime opportunities
16 for development of high volume waste reduction, reuse and recycling
17 programs. Improved materials management and waste management
18 programs in schools and other institutions across the state will contribute
19 significantly to local governments' ability to meet or exceed AB 939 goals.
20

21 A partnership between the school districts, local governments and the
22 Board has significant benefits for both partners. School officials and
23 managers are not experts in the management of wastes or mindful of the

1 opportunities the materials management system provides for cost savings
2 and other benefits; and

3 **WHEREAS,** A partnership with the Board and local governments
4 provides schools with the expertise to achieve financial, educational, and
5 community benefits. The partnership also provides the Board an
6 opportunity to develop the staff expertise and program techniques with
7 which to implement a model program statewide, thereby enhancing the
8 probability of meeting AB 939 goals. As with any good partnership,
9 mutual and respective objectives are achieved that could not be achieved
10 otherwise; and

13 **WHEREAS,** The San Francisco Recycling Program plans to work with no
14 fewer than five schools and up to eight schools to offer technical support
15 to implement comprehensive efforts at schools sites that incorporate
16 waste reduction, recycling, composting and procurement of recycled
17 products.

19 **A sample of projects we are currently considering include:**

21 Retread tire surfaces for playgrounds
22 Recycled playground equipment
23 Reused and or recycled gardening materials
24 Permanent dishes and dishwashers in cafeteria

1 Composting collection program

2 Capital for environmental enhancements

15 **WHEREAS**, The City Administrator is requesting a waiver of "indirect cost"
16 for the administrative fees subject to be incurred upon, The City and
17 County of San Francisco during the grant "accept and expend" procedure;

19 **WHEREAS**, The California Integrated Waste Management Board has
20 approved a grant of \$50,000 in funds for school waste prevention and
21 recycling programs;

1 **NOW THEREFORE BE IT RESOLVED**, that the Board of Supervisors
2 hereby authorizes the City Administrator to accept and expend \$50,000
3 grant from the California Integrated Waste Management Board; and


5 **FURTHER RESOLVED**, That the Board of Supervisors does hereby




