COMMENDING CONSUMERS IN ACTION FOR PERSONAL ASSISTANCE FOR THEIR EFFORTS TO EDUCATE AND PERSUADE DISABILITY SERVICE PROVIDERS TO BETTER SERVE THEIR CLIENTS BY OFFERING VOTER REGISTRATION.

WHEREAS, We are celebrating the tenth anniversary of a landmark civil rights law, the Americans with Disabilities Act; and,

WHEREAS, The City and County of San Francisco prides itself on being open to all and to supporting all communities in their struggle for full inclusion in our society; and,

WHEREAS, Citizens with disabilities are the nation's largest minority, comprising a fifth of the population; and,

WHEREAS, Voter registration and voter turnout rates for people with disabilities are far lower than the rest of the population, making the disabled a sleeping giant in American politics; and,

WHEREAS, People with disabilities are less likely to be registered to vote than people without disabilities by a gap of 16 percentage points (62% versus 78% respectively); and,

WHEREAS, People with disabilities vote at a rate 20 percent below non-disabled voters; and,

WHEREAS, The National Organization on Disability (NOD) and a San Francisco selfadvocacy group, Consumers in Action for Personal Assistance (CIAPA) are using the 1993 National Voter Registration Act (The Motor Voter Law) to get people with disabilities registered to vote in time for the November 2000 election; and,

WHEREAS, The Motor Voter Law requires disability service providers to offer voter registration to their clients; and,
