WAIVING PARKING CONTROL OFFICER FEE OF \$385.60 CHARGED TO RACHEL KAPLAN FOR ORGANIZING AND STAGING A PERFORMANCE PROTEST ON AUGUST 22, 2000.

WHEREAS, A performance protest was convened on August 22, 2000 from 7:00 to 12:00 PM to call attention to the plight of dance performance artists, choreographers, film makers, musicians and other members of the performing arts community; and

WHEREAS, Many dance performance studios have either been evicted or displaced because of a recent dramatic escalation of rents in San Francisco with some rents going up nearly 500%; and

WHEREAS, Dancers, musicians, actors, puppet performance artists, poets as well as community leaders and concerned citizens from the all over the San Francisco participated in the event to voice their concerns about the imperiled dance performance and arts community; and

WHEREAS, The local dance performance community, second only to New York City, is endangered by escalating rents, severe shortage of rehearsal space, and displacement by high tech and Internet companies ; and

WHEREAS, The local dance performance and arts community contributes significantly cultural vibrancy and uniqueness to the City and it is in the best interest of the City to devise strategies to preserve and enhance artistic creativity and economic viability of this community; and

WHEREAS, The performance protest event was held on August 22, 2000 in which 22nd Street and blocked off from Mission Street to Bartlett Street to vehicular traffic and required the assistance of Parking Calming Officers to monitor traffic flow of the intersection; now therefore be it


