ADOPTING FINDINGS PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT, AND ENACTING AND RESCINDING PARKING AND TRAFFIC REGULATIONS ON PORTIONS OF MISSION STREET AND JESSIE STREET.

WHEREAS, In Resolution No. 812-00, a copy of which is on file with the Clerk of the Board of Supervisors in File No. 001265, this Board of Supervisors affirmed the Planning Commission's and Redevelopment Commission's certification of the Final Supplemental Environmental Impact Report for the Yerba Buena Redevelopment Project Area Expansion/Emporium Site Development (SCH. No. 98072072) (the "FSEIR") as adequate and complete pursuant to the California Environmental Quality Act ("CEQA"), the State CEQA Guidelines, and Chapter 31 of the San Francisco Administrative Code. In such Resolution, this Board also adopted findings in connection with the FSEIR, including an Addendum thereto, and its actions related to the Yerba Buena Redevelopment Project Area Expansion, including the actions contemplated herein, and adopted a mitigation monitoring and reporting program;

WHEREAS, On August 1, 2000, the Parking and Traffic Commission unanimously recommended the regulatory changes listed in this Resolution; now, therefore be it
