9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Section 10.117-119 is added to the San Francisco
12 Administrative Code, to read as follows:

13 **SEC. 10.117-119. Excelsior Youth Center.** (a) The Director of
14 the Mayor's Office of Community Development is hereby authorized to
15 accept and expend, on behalf of the City and County of San Francisco,
16 all gifts made to the City and County of San Francisco, including
17 gifts exceeding Five Thousand Dollars (\$5,000), for the development,
18 construction, furnishing, operation and maintenance of the Excelsior
19 Youth Center.

20 (b) All cash gifts, donations and contributions of money that
21 may be offered for the Excelsior Youth Center are hereby accepted for
22 such purpose, and when received, such monies shall be deposited in
23 the treasury of the City and County in a special fund to be known as
24 the "Excelsior Youth Center Fund." Pursuant to the San Francisco
25 Annual Appropriation Ordinance, the Controller is directed to set up






