

[Parking Regulations]

ADDING SECTION 32.6.18 TO THE SAN FRANCISCO TRAFFIC CODE, REGARDING PARKING REGULATIONS ON A PORTION OF THE SOUTH SIDE OF REDWOOD STREET, WEST OF POLK STREET, FROM 8 A.M. TO 5 P.M., MONDAY THROUGH FRIDAY.

Note: This entire section is new.

Be it ordained by the people of the City and County of San Francisco:

Section 1. The San Francisco Traffic Code is hereby amended by adding Section 32.6.18 thereto to read as follows:


SEC. 32.6.18. PARKING CONTROL, PORTION OF REDWOOD STREET, FROM 8 A.M. TO 5 P.M., MONDAY THROUGH FRIDAY; PENALTIES FOR VIOLATION. No person shall stop, park, or leave standing any vehicle, whether attended or unattended, from 8 a.m. to 5 p.m., Monday through Friday, on the south side of Redwood Street, from 35 feet to 115 feet west of Polk Street, except official City-owned vehicles displaying a valid permit issued by the City Administrator's Office authorizing parking in such zones. The permit exceptions under this Section shall not apply when parking prohibition regulations for street-cleaning purposes are in effect. Violation of this Section is an obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of the Civil Code of California relating to nuisance and the abatement thereof.




