AMENDING ARTICLE 3. CHAPTER XI, PART II OF THE SAN FRANCISCO MUNICIPAL CODE (TRAFFIC CODE) BY AMENDING SECTION 33, REGARDING TEMPORARY NO-PARKING SIGNS TO INCLUDE A CONTACT PERSON AND TELEPHONE NUMBER FOR INFORMATION REGARDING THE REASONS FOR THE RESTRICTIONS.

Note: Additions are underlined; deletions are in ((double parentheses)). Be it ordained by the People of the City and County of San Francisco:

Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by amending Section 33. to read as follows:

SEC. 33. DIVERTING OF TRAFFIC AND TEMPORARY PARKING RESTRICTIONS.

Diverting of Traffic. The Police Department may divert traffic from any street or (a) area when the same is made necessary or advisable by any parade, public assemblage, film or video production, traffic congestion, conflagration, collapse of building, obstruction on or damage to any street or any other emergency.

Parking Temporarily Prohibited or Restricted in Certain Cases. The Police (b) Department or the Department of Parking and Traffic may temporarily prohibit or restrict automobile parking on any street in case of parades, public assemblages, film or video production, collapse of building, conflagration, obstruction on or damages to any street, or when otherwise necessary for protection of the public health and safety, provided appropriate signs which shall include a contact person and telephone number for information regarding the reasons for the restrictions are erected giving notice of such prohibition or restriction. The contact person shall be available to respond to inquiries during business hours. TT

(c) **Violation.** It shall be unlawful for any person to park a vehicle in violation of such prohibition or restriction or to disobey the lawful order of any Police Officer or Parking Control Officer directing the removal or diverting of a vehicle from said street or area.
