2 AMENDING THE RULES OF ORDER OF THE BOARD OF SUPERVISORS BY ADDING
3 RULE 5.10.1 TO CREATE A CITY AND SCHOOL DISTRICT COMMITTEE OF THE BOARD
4 OF SUPERVISORS, AND BY AMENDING RULE 5.13 TO PROVIDE THAT THIS
5 COMMITTEE SHALL BE COMPRISED OF TWO SUPERVISORS AND TWO MEMBERS OF
6 THE BOARD OF EDUCATION.

7 WHEREAS, There is a need for the City and County of San Francisco and the San
8 Francisco Unified School District to work together on issues of mutual interest that affect the
9 City and the School District, its employees, its students and the families of its students,
10 including the issue of the public use of School District facilities; and

11 WHEREAS, The Board of Supervisors wishes to create a Committee that would allow,
12 and encourage, members of the public and representatives of both the Board of Supervisors
13 and the Board of Education of the School District to discuss issues of mutual interest and to
14 develop recommendations for action for both the Board of Supervisors and the Board of
15 Education; now, therefore, be it

16 MOVED, That Rule 5.10.1 is added to the Rules of Order to read:

17 **Rule 5.10.1. City and School District Committee.** To the City and School District
18 Committee shall be referred measures concerning issues of mutual interest that affect the City
19 and the School District, its employees, its students, and the families of its students, including
20 the issue of the public use of School District facilities.

21 FURTHER MOVED, That Rule 5.13 is amended to read:

22 **Rule 5.13. Committee Size.** Each standing committee and special committee, except
23 the City and School District Committee, shall be comprised of three Board members. The City
24 and School District Committee shall be comprised of two Board members, and the Board of
25 Education of the San Francisco Unified School District shall be invited to appoint two of its

members to serve on the City and School District Committee.

FURTHER MOVED, That the Board of Supervisors and the Board of Education shall share, equally, the responsibilities of staffing the meetings of this Committee, as well as any necessary expenses in support of the activities of this Committee.

FURTHER MOVED, That these amendments to the Rules of Order of the Board of Supervisors shall take effect on August 1, 1999.


