aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated November 7, 2006. (4) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (5) The sale of any beer and/or malt product(s) is strictly prohibited.
