3 **Resolution authorizing the Recreation and Park Department to re-appropriate \$527,221**
4 **of Proposition 40, AB 716 Grant Program funds from the Urban Forestry Yard project to**
5 **the South Murphy Windmill Project.**

7 WHEREAS, the Legislature and Governor of the State of California have approved a
8 grant for \$32,673,000 for various projects in Golden Gate Park; and

9 WHEREAS, the Board of Supervisors, through resolution number 100-04, approved the
10 acceptance and expenditure of the grant funds for various projects including \$783,000 for the
11 Urban Forest Yard project; and

12 WHEREAS, due to (1) anticipated construction escalation costs, (2) the expiration
13 timeline of the secured California Coastal Conservancy grant funds allocated for this project
14 (April 2007 expiration), (3) the continued cost increases to store the completed windmill cap
15 (phase 1A) in the Netherlands; and

16 WHEREAS, the Recreation and Park Department requires an additional \$527,221 to
17 complete the Murphy Windmill Phase IB project; and

18 WHEREAS, the Recreation and Park Commission through resolution number 0608-008
19 recommends that the Board of Supervisors re-appropriate \$527,221 from the Urban Forestry
20 Yard project to the Murphy Windmill restoration project; now, therefore, be it

21 RESOLVED, that the Board of Supervisors approves the re-appropriation of
22 Proposition 40, AB 716 Grant Program funds in the amount of \$527,211 from the Urban
23 Forestry Yard project to the Murphy Windmill project.
