Resolution authorizing the San Francisco Department of Public Health to retroactively accept and expend a grant in the amount of \$30,000 from the California Department of Health Services to mitigate the threat of West Nile virus transmission through mosquito control activities, for the period of July 1, 2006 to June 30, 2007.

WHEREAS, The California Department of Health Services, Vector Borne Disease Section (DHS-VBDS) awarded the San Francisco Department of Public Health Environmental Health Section (DPH-EHS) an award for \$30,000 to enhance and expand mosquito control activities to reduce the risk of West Nile virus transmission to residents of San Francisco; and,

WHEREAS, These funds will allow the DPH-EHS Mosquito Control program to do more effective mosquito control by partially funding two Public Service Aides to offer inspections of properties where mosquito activity is reported or suspected and develop and distribute mosquito control educational materials; and,

WHEREAS, The grant does not require an ASO amendment and reimburses the department for two existing, temporary Public Service Aides (Job Class 9924) at $0.80 \ 2.0$ FTE (.4 <u>1.0</u> x 2) from March <u>July</u>, 2006 through June 30, 2007; and

WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now therefore, be it

RESOLVED, That SFDPH is hereby authorized to retroactively accept and expend a grant in the amount of \$30,000 from the California DHS-VBDS; and, be it

FURTHER RESOLVED, That SFDPH is hereby authorized to retroactively accept and expend the grant funds in accordance with the requirements set forth in the Agreement, pursuant to San Francisco Administrative Code section 10.170-1; and, be it

Department of Public Health BOARD OF SUPERVISORS FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the budget of the Agreement; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
