Resolution authorizing the San Francisco Department of Public Health (DPH) to accept and expend retroactively a grant in the amount of \$12,760 from the University of California San Francisco (UCSF), to assist with a project entitled "HPV Epidemiology and Response to Screening;" for the period of August 11, 2009 through July 31, 2010.

WHEREAS, UCSF is the recipient of a grant award from the National Institutes of Health (NIH) to support the project entitled "HPV Epidemiology and Response to Screening;" and,

WHEREAS, Through this grant, UCSF has agreed to fund DPH in the amount of \$12,760 for the period of August 11, 2009 through July 31, 2010; and,

WHEREAS, This award is issued under the American Recovery and Reinvestment Act (ARRA) of 2009; and,

WHEREAS, It is considered in the best interested of the NIH, UCSF and DPH to collaborate on this project; and,

WHEREAS, This grant project will be extended by UCSF to July 31, 2011 in the total amount of \$19,324 if DPH meets all of the funder's requirements in the first year; and,

WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 091357; which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH for one existing position, Senior Physician Specialist (Job Class #2232 at 0.05 FTE) for the period of August 11, 2009 through July 31, 2010; and,

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate all positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
