APPROVING HOLD HARMLESS PROVISIONS FOR THE WASTEWATER AGENCY RESPONSE NETWORK AND WATER AGENCY RESPONSE NETWORK OMNIBUS MUTUAL AID AGREEMENTS

WHEREAS, California Government Code, section 895, authorizes cities and other public entities to enter consensual mutual aid agreements under which the entities agree to perform functions, services or acts with or for other participating public entities; and,

WHEREAS, this provision also authorizes public entities, as part of these agreements, to provide for contribution or indemnification by any or all of the public entities that are parties to the agreement upon liability arising out of the performance of the agreement; and,

WHEREAS, the Public Utilities Commission has entered into a mutual aid agreement, providing for mutual assistance among water agencies in times of emergency; and,

WHEREAS, the Water Pollution Control Division of the Public Utilities Commission desires to enter into a similar mutual aid agreement, providing for mutual assistance among local wastewater agencies in times of emergency; and

WHEREAS, these agreements include two hold harmless provisions providing that agencies receiving aid will fully indemnify and hold harmless those agencies providing the aid and separately providing that agencies rendering or receiving aid will indemnify and hold harmless all other signatory agencies whose only involvement is through participation in executing and approving the Agreement; and,

WHEREAS, The consent of the Board of Supervisors is a necessary prerequisite to the execution of the hold harmless provisions for the benefit of the other parties in the Agreements detailed above; now, therefore, be it

RESOLVED, that the Board of Supervisors hereby authorizes the Public Utilities

Agreement which includes hold harmless provisions providing that: (1) agencies borrowing equipment, supplies or personnel shall assume the defense of, fully indemnify and hold harmless other agencies lending equipment, personnel or supplies from all claims, loss, damage, injury and liability directly or indirectly arising from the borrowing agencies work under the agreement, and (2) in the event of a liability, claim, demand, action or proceeding arising out of the rendering of assistance through the agreement, the parties involved in harmless rendering or receiving assistance will indemnify and hold/each signatory whose only involvement in the transaction or occurrence which is the subject of such claim, action, demand or other proceeding, is the execution and approval of the agreement; and be it

FURTHER RESOLVED, that the Board of Supervisors hereby ratifies the action previously taken by the Public Utilities Commission in signing the Water Agency Response Network Omnibus Mutual Aid Agreement containing hold harmless provisions similar to those mentioned above.
