[Contract funds to support participation in an international HIV/AIDS study.]

Resolution authorizing the San Francisco Department of Public Health (DPH) – AIDS Office, to enter into an agreement with Blood Systems Research Institute (BSRI) and to retroactively accept and expend funds in the amount of \$12,192 for a project entitled Retrovirus Epidemiology Donor Study – II (REDS-II) – International; for the period of January 1, 2007 through April 30, 2007.

WHEREAS, BSRI was awarded funds through the National Institutes of Health for the REDS-II – International program, and has agreed to reimburse DPH-AIDS Office in the amount of \$12,192 under the terms of this contract agreement; and,

WHEREAS, The goals of this project are a) study management, b) liaise with Brazilian sites participating in the study, and c) assistance with data management; and,

WHEREAS, As a condition of receiving these funds, BISR requires DPH to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 070395; which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, This resolution requires expedited review by the Board of Supervisors because DPH received the award letter from BISR on March 12, 2007, and the date of the agreement is January 1, 2007 through April 30, 2007; and,

WHEREAS, The budget includes a provision for indirect costs of \$2,011; now, therefore, be it

RESOLVED, That DPH – AIDS Office, is hereby authorized to retroactively enter into a contract agreement in the amount of \$12,192 with BSRI, the lead agency; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.
