Be it ordained by the People of the City and County of San Francisco:

Section 1. Chapter 8 of the San Francisco Administrative Code is hereby amended by adding Section 8.40, to read as follows:

SEC. 8.40. Department of Public Works ("DPW") Geographic Information System ("GIS") Data License Agreements -: Ratification of Prior Fees.

<del>(a)</del> —	License Fees. The Director of the Department of Public Works, the Director of
	any other department responsible for administering the City and County of San
	Francisco's Geographic Data Services Program, or his or her designee
	("Director"), is hereby authorized to enter into licensing agreements authorizing
	third party use of the City and County of San Francisco's computer mapping
	system and data, known as the Base Map Geographic Information System
	("GIS") data, and charge license fees thereunder that are consistent with the fair
	market value of the GIS. In addition, the Director, in his or her discretion, may

Mayor Department of Public Works BOARD OF SUPERVISORS establish standard reduced fee rates for non-profit organization licensees of the GIS.

(b) Ratification of Prior Fees. All fees previously collected by the City under GIS data license agreements entered into since July 1, 1998 and before the effective date of this Section are hereby ratified.

Section 2. **Severability.** If any part of this Ordinance, or the application thereof to any person or circumstance, is held invalid, the remainder of this Ordinance, including the application of such part or provision to other persons or circumstances, shall not be affected thereby, and this Ordinance shall continue in full force and effect. To this end, the provisions of this Ordinance are severable.
