RESOLVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated person to serve as a member of the San Francisco Health Authority, pursuant to the provisions in the Welfare and Institutions Code Sec. 14087.36 and the San Francisco Administrative Code Sections 69.1 et seq., for the term specified:

Grant Davies (residency requirement waived), succeeding John Williams, term expired, seat 4, must be senior manager of St. Luke's Hospital, for the unexpired portion of a three-year term ending January 15, 2009; and, be it

FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- The membership of the San Francisco Health Authority has a goal to be representative of the diversity of the City and County of San Francisco;
- 2. Applicant Grant Davies, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the Health Authority;
