WHEREAS, California law greatly increased the revenue received from each red light violation citation to provide adequate funding to cover all operational costs of the Red Light Photo Enforcement Program; and,

WHEREAS, The Parking and Traffic Commission has authorized the expansion of the Red Light Photo Enforcement Program, which is currently underway;

WHEREAS, The State of California, Department of Transportation has offered eleven photo-enforcement cameras for the following intersection:

Park Presidio Boulevard and Lake Street

Park Presidio and Geary Boulevards

Park Presidio Boulevard and Fulton Street

Marina Boulevard and Lyon Street
