AUTHORIZING THE GENERAL MANAGER OF THE PUBLIC UTILITIES COMMISSION TO APPLY FOR, ACCEPT AND EXPEND A GRANT OF UP TO \$150,000 FROM THE U.S. ENVIRONMENTAL PROTECTION AGENCY FOR WET WEATHER AND POINT SOURCE POLLUTION CONTROL PROJECTS.

WHEREAS, the U.S. Environmental Protection Agency has remaining fiscal year 1998 grant funds available for Wet Weather and Point Source Pollution Control Projects in the amount of \$111,000, and the EPA has verbally committed in fiscal year 1999 to fund the balance of the SFPUC grant proposal for a total of \$150,000; and,

WHEREAS, the San Francisco Board of Supervisors has urged the SFPUC to study "environmentally beneficial alternatives so that the best available options can be selected to provide long-range solutions to the overall problems of the City's wastewater flows into the Bay;"; and,

WHEREAS, San Francisco has a unique opportunity along the City's eastern watershed to investigate decentralized, alternative wastewater technologies for stormwater and sanitary flows; and,

WHEREAS, the SFPUC would work with civic and environmental groups in conducting a detailed study of the city's eastern watershed and identify appropriate alternative technologies for that geographic area, the analyses of which would be folded into the PUC's overall Strategic Plan for Wastewater; now, be it

RESOLVED, that the General Manager of the SF Public Utilities Commission to authorized to apply, accept and expend up to \$150,000 in grant funding from the U.S. E.P.A.




