RESOLVED, that *The Bay Area Reporter* and *The San Francisco Bay Times*, newspapers which circulate primarily in the Lesbian, Gay, Bisexual, Transgender (LGBT) community of San Francisco and which is printed in San Francisco on one or more days in a calendar week, is hereby designated as the outreach newspaper of the City and County of San Francisco for the LGBT community, commencing July 1, 2007, for the publication of outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it

RESOLVED, that the Office of Contract Administration is hereby authorized to enter into contracts with *The Bay Area Reporter* and *The <u>San Francisco</u> Bay Times* and said contracts must fully comply with all the contracting requirements of the City and County of San Francisco.
