WHEREAS, San Francisco is facing the most severe shortage of affordable rental housing since World War II; and,

WHEREAS, The Board of Supervisors placed a Declaration of Policy on the June, 1998 ballot which asked "Shall the City and County of San Francisco, which has been asked to pay for and provide non-emergency support services to the Presidio, encourage the restoration of the land to natural open space, and act to ensure that the 1,900 existing housing units at the Presidio, including Wherry Housing, be preserved at the Presidio, with the majority of that existing housing to be set aside for rental to San Francisco residents of all income levels, including both affordable and market-rate housing?" and this Declaration of Policy was Proposition L on the ballot; and,

WHEREAS, Proposition L was passed by 93,002 of San Francisco voters, representing 53.1% of the vote; now, therefore, be it

RESOLVED, That the City and County of San Francisco supports and urges the Mayor's Office of Housing to submit a proposal to the Presidio Trust for a substantial portion of Wherry Housing to be leased by the City and County of San Francisco or made available to

the City and County through employment or other agreements that will provide housing for low income San Franciscans and San Franciscans at risk of homelessness.
