WHEREAS, On April 23, 1998, PUC Sewer Operations identified an emergency condition on Vallejo Street from Van Ness Avenue to Polk Street; and

WHEREAS, The existing sewer had failed, and immediate repairs were required in order to protect the health, welfare, and property of the Citizens of San Francisco; and

WHEREAS, DPW's Bureau of Engineering prepared Plans and Specifications for Contract No. CW-176, "Vallejo Street Emergency Sewer Replacement" to replace the existing 3'x5' brick sewer with 412 feet of 48-inch reinforced concrete pipe (RCP) and 33 feet of 24-inch diameter vitrified clay pipe (VCP) sewer on Vallejo Street from Van Ness Avenue to Polk Street; and

WHEREAS, The Contractor, JMB Construction, Inc. began the emergency work on May 18, 1998 and completed it on July 6, 1998; and

WHEREAS, The total estimated project cost is \$260,112, of which \$206,962 is for the construction contract. Funds for this project are available from the 1994 Sewer Bond (Fund 5C/CPF/95A, FAMIS Project No. CENSR4SI33, Job Order No. 1604N); and

WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section 6.30 of the Administrative Code of the City and County of San Francisco, declared the existence of an emergency; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for the emergency work to repair the structurally inadequate sewer on Vallejo Street from Van Ness Avenue to Polk Street.
