24 25 [Bicycle Legislation - Extension of Planning Commission Review Period] EXTENDING THE PRESCRIBED TIME WITHIN WHICH THE PLANNING COMMISSION MAY RENDER ITS DECISION ON THE PROPOSED BICYCLE TRANSIT ENHANCEMENT PLAN ORDINANCE, FOR AN ADDITIONAL 45 DAY PERIOD ENDING ON NOVEMBER 13, 1998.

WHEREAS, On April 6, 1998, the Board of Supervisors initiated the process to amend the Municipal Code, Part II, Chapter II (Planning Code), when the Honorable Leslie Katz introduced a proposed ordinance, entitled the "Bicycle Transit Enhancement Plan," a copy of which is on file with the Clerk of the Board of Supervisors in File No. 98-0564; and,

WHEREAS, The proposed ordinance would amend Article 1.5 of the Planning Code with respect to general standards as to location and arrangement of off-street parking, bicycle parking requirements for city-owned and leased buildings, bicycle parking requirements for city-owned parking garages and privately-owned parking garages as well as requirements for shower and locker facilities in new commercial and industrial buildings and existing buildings undergoing major renovations; and,

WHEREAS, On July 1, 1998, the proposed ordinance, as amended by substitute legislation on June 29, 1998, was referred to the Planning Commission, which is currently reviewing the proposed ordinance; and,

WHEREAS, Section 306.4(d) of the Planning Code requires that the Planning Commission render a decision regarding proposed amendments to the Planning Code within 90 days from the date of referral of such amendments to the Planning Commission; and

WHEREAS, the current 90 day period for the Planning Commission's review of the proposed amendments expires on September 29, 1998; and

WHEREAS, The Zoning Administrator has requested additional time to review the proposed ordinance; and,

SUPERVISOR KATZ, BROWN, TENG BOARD OF SUPERVISORS

WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by resolution, extend the prescribed time within which the Planning Commission is to render its decision on proposed amendments to the Planning Code initiated by the Board of Supervisors; and,

WHEREAS, The Board deems it appropriate in this instance to grant to the Planning Commission an additional 90 days to review the proposed ordinance and render its decision; now, therefore, be it

RESOLVED, That by this resolution, the Board hereby extends the prescribed time within which the Planning Commission may render its decision on the proposed Bicycle Transit Enhancement Plan ordinance, for an additional 45 day period ending on November 13, 1998.
