RESOLVED, That the Director of Aging and Adult Services be hereby authorized to accept and expend a gift of \$37,000 from the San Francisco Hospital Council, acting through Health Plus Services, for the purpose of creating a liaison program between member hospitals and the San Francisco Public Guardian, pursuant to an agreement to be executed between the City and Health Plus Services, copy attached hereto; and, be it

FURTHER RESOLVED, That the Public Administrator-Public Guardian is authorized to create a Limited-Term position of job code 2588 Health Worker IV to perform this liaison function, subject to the condition that all costs attendant to this position shall be funded from the proceeds of this gift, copy of budget attached hereto, and that should this funding be cancelled or withdrawn, then the authorization for this position shall terminate as well.
