4 **Resolution approving and authorizing the execution of Modification No. 6 to the Lease**
5 **and Use Agreement L-82-0134 with Alaska Airlines, Inc., to realign terminal space in**
6 **Terminal 1 of San Francisco International Airport.**

8 WHEREAS, Alaska Airlines, Inc. ("Alaska") currently conducts its passenger operations
9 at Terminal 1 and International Terminal of San Francisco International Airport ("Airport"),
10 pursuant to Lease No. 82-0134 between Alaska and the City and County of San Francisco,
11 acting by and through its Airport Commission having a thirty-year lease term that expires June
12 by 30, 2011 (the "Lease"); and

13 WHEREAS, Alaska and Airport agreed to modify the Agreement to reflect changes in
14 the Joint Use versus Exclusive Use nature of certain of Alaska's Category II and Category IV
15 space in Terminal 1 and other minor modifications to Alaska's leasehold; and

16 WHEREAS, Airport staff has negotiated the modification with Alaska which is in the
17 best interest of the Airport; and

18 WHEREAS, On May, 2007, pursuant to Resolution No. 07-0119, the Airport
19 Commission approved Modification No. 6 to the Lease; and

20 WHEREAS, A copy of the form of the Modification is on file with the Clerk of the Board
21 of Supervisors in File No. _____, which is hereby declared to be a part of this resolution
22 as if set forth fully herein; now, therefore, be it

23 RESOLVED, That this Board of Supervisors hereby approves and authorizes the
24 execution of Modification No. 6 to the Lease and Use Agreement L-82-0134 for terminal
25 space in Terminal 1 of the Airport, between Alaska Airlines, Inc., and the City and County of
San Francisco, acting by and through its Airport Commission.


