Be it ordained by the People of the City and County of San Francisco:

Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth the findings made by the Planning Department in its letter dated August 7, 2003, which stated that the actions contemplated herein are consistent with the General Plan. Section 2. In accordance with the Department of Public Works' Order No. 174,390 a copy of which is in the Clerk of the Board of Supervisors File No. 031695, Board of Supervisors Ordinance No. 1061, entitled "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a new section to read as follows:

Section 1561. The width of sidewalks on the south side of Market Street west of Third Street; shall be modified as shown on Department of Public Works drawing Q-20-558, a copy of which is in the Clerk of the Board of Supervisors

File No. 031695

Section 3. Millennium Partners, the project sponsor who proposes to undertake the sidewalk construction to implement the sidewalk width changes, is required to make arrangements with public utilities and City Departments concerning relocation, modification, or both of facilities in the affected sidewalk and street areas. Any necessary relocation, modification, or both of such facilities shall be at no cost to the City and County of San Francisco.
