WHEREAS, The Annie E. Casey Foundation has made available funding for activities and technical assistance that will advance the principles of the Juvenile Detention Alternatives Initiative (J.D.A.I.) benefiting the Juvenile Probation Department of the City and County of San Francisco; and

WHEREAS, Due to the need for the development of strategies, practices and detention alternative programming, the Juvenile Probation Department will seek and develop commensurate in-service training curricula, sponsor meetings and retreats of the J.D.A.I. collaborative, and facilitate parent, youth advisory group development; and,

WHEREAS, The Juvenile Probation Department will use a portion of the grant funds to hire a project coordinator (1842) at 0.75 FTE for nine months to develop strategies and practices that will support the implementation of a comprehensive plan designed to address the disproportionate representation of minority youth in the juvenile justice system and produce better outcomes for Juvenile Probation Department involved youth over time; and

WHEREAS, the Juvenile Probation Department has been selected to receive an unconditional, unrestricted grant in the amount of \$125,000 from the Annie E. Casey Foundation; now, therefore, be it
