

[Changing the official sidewalk width – Berry Street]

Ordinance amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks” by adding thereto Section 1577 to change the official sidewalk width on the northerly side of Berry Street between 7th and DeHaro Streets; making environmental findings and findings pursuant to the General Plan and Planning Code Section 101.1; and requiring relocation, modification, or both of facilities affected by the sidewalk width change.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth the Planning Department findings in its letter dated May 22, 2007. Said letter stated the actions contemplated herein are consistent with the General Plan and in conformance with the Eight Priority Policies of Planning Code Section 101.1. A copy of said such letter is in the Clerk of the Board of Supervisors File No. 080138

Section 2. In the abovementioned letter, the Planning Department also determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality ACT (California Public Resources Code sections 21000 et seq.). Said determination is incorporated herein by reference.

Section 3. In accordance with the Department of Public Works' No. 177,302, a copy of which is in the Clerk of the Board of Supervisors File No. 080138

6 between 7th and DeHaro Streets shall be 10 feet.


7 Section 4. Sandis c/o 601 King Street, as is necessary as a result of this




