Conditions: (1) Petitioner(s) shall not permit their patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. Patrons standing in line to enter the premises shall not be considered loitering or unlawfully gathering. (2) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (3) Sale and service of alcoholic

beverages shall be allowed between the hours of 8:00 a.m. and 6:00 p.m. each day of the week. (4) The sales of alcoholic beverages shall be restricted to the sale of wine only. At no time shall beer and/or malt products be on the premises.
