FURTHER RESOLVED, That the City and County of San Francisco certifies that Grantee has or will have sufficient funds to operate and maintain the project(s); and, be it FURTHER RESOLVED, That the City and County of San Francisco certifies that

Grantee has reviewed, understands and agrees to the General Provisions contained in the Contract shown in the Procedural Guide; and, be it

FURTHER RESOLVED, That the City and County of San Francisco certifies that the Project conforms to the recreation element of any applicable city or county general plan; and, be it

FURTHER RESOLVED, That the City and County of San Francisco appoints the General Manager of the Recreation & Park Department as agent to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, payment requests and so on, which may be necessary for the completion of the aforementioned project.
