Be it ordained by the People of the City and County of San Francisco:

"Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors
Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a
new section to read as follows:

Section 1580. The official sidewalk width on the southerly side of Golden Gate Avenue shall be as shown on Department of Public Works drawing Q-20-647, copies of which are in the Clerk of the Board of Supervisors File No. 080845

Section 4. Hasting College of the Law, University of California, as is necessary as a result of this Ordinance, shall make arrangements with public utility companies and City Departments for the relocation, modification, or any affected public facilities. Any necessary relocation, modification, or both of such facilities shall be at no cost to the City and County of San Francisco.
