3 **Resolution authorizing the Airport Commission to accept and expend three (3) grants**  
4 **totaling \$414,340 from the Bay Area Air Quality Management District (Air District) for**  
5 **acquisition of clean air vehicles by Airport transportation operators.**

7 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle  
8 emissions in the region and on terminal roadways; and

9

10 WHEREAS, The Air District assists public agencies in implementing emissions  
11 reduction projects, such as the addition of clean air vehicles to fleets; and,

13 WHEREAS, The Airport Commission in Resolutions 05-0107 and 06-0026 approved  
14 seeking, accepting, and expending Air District funds for clean air vehicles; and

15

16 WHEREAS, The Airport would administer this grant, disburse incentive funds to airport  
17 transportation operators, and provide the Air District with information concerning the new  
18 vehicles; and

19

20 WHEREAS, No Airport or City funds would be used for this program; and

21

22 WHEREAS, This demonstration project would continue the Airport's leadership role in  
23 promoting clean fuel use among transportation providers; and

25 WHEREAS, The Airport proposes to maximize use of available grant funds on program  
expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That, pursuant to San Francisco Administrative Code §10.171, the Board

of Supervisors does hereby authorize the Airport Commission to accept and expend funds


awarded in this grant; and be it


