Conditions: 1) The hours of operation shall not exceed 10:00 a.m. to 2:00 a.m. Sunday through Wednesday and 10:00 a.m. to 3:00 a.m. on Thursday, Friday and Saturday. The following exceptions(s) shall not constitute a violation of this condition: New Years Eve and five (5) additional days per calendar year may exceed the aforementioned hours and days, subject to the petitioner attaining Department authorization two weeks prior to utilizing said exception. 2) No "happy hour" type of reduced price alcoholic beverage promotion shall be allowed. 3) There shall be no coin pperated games or video machines maintained upon the premises at any time. 4) Entertainment provided shall not be audible beyond the area under the control of the icensee(s). 5) No person under the age of twenty-one (21 years of age) shall sell, furnish, or deliver alcoholic beverages. 6) The sale of alcoholic beverages for consumption off the premises is strictly prohibited. 7) Petitioner shall not permit its patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. The orderly standing of patrons in line to enter the premises shall not be considered loitering or unlawfully congregating. 8) The petitioner(s) shall be esponsible for maintaining free of litter the area adjacent to the premises over which they have control. 9) At any time the premises are providing live entertainment, the petitioner(s) shall provide security personnel that shall maintain order therein and prevent any activity which would interfere with the quiet enjoyment of their property by hearby residents. Said personnel shall be clothed in such a manner as to be readily dentifiable as security. 10) Petitioner shall not make structural changes in the premises interior without prior written approval from the Department. 11) The interior ighting maintained therein shall be sufficient to make easily discernible the appearance

and conduct of all persons and patrons in that portion of the premises where alcoholic beverages are sold, served, delivered or consumed. 12) The exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises.

Additionally, the position of such lighting shall not disturb the normal private and use of any neighboring residences. 13) At no time shall any person under the age of 21 years enter or remain in this public premises.
