Resolution establishing the Appropriations Limit for Fiscal Year 2001-02 pursuant to California Constitution Article XIII B.

WHEREAS, Article XIII B of the California Constitution provides that the annual appropriations of the City and County of San Francisco which are subject to said Article may not exceed the Appropriations Limit for the prior year, with adjustments as provided in said Article XIII B; and

WHEREAS, The California Government Code, Sections 7901-7914, defines the terms and sets forth the equations to be used to determine San Francisco's annual appropriations limit; and

WHEREAS, The resulting calculation establishing San Francisco's 2001-02 Appropriations Limit is:

 $1,569,917,337 \times 1.078200 \times 1.014400 = 1,717,059,535$ ; and

WHEREAS, For future Appropriations Limit calculations pursuant to said Article, the City will use the gross appropriations limit of \$1,717,059,535; and

WHEREAS, This matter has been considered at a regularly scheduled meeting of the Board of Supervisors for the City and County of San Francisco; and

WHEREAS, The documentation used to determine the Appropriations Limit for the City and County of San Francisco for fiscal year 2001-02 was available for public inspection in the

office of the Clerk of the Board of Supervisors for at least fifteen (15) days prior to said regularly scheduled meeting; now, therefore, be it

RESOLVED, That the City and County of San Francisco elects to use the percentage change in California per capita personal income from the previous year as the measure of "change in the cost of living" for purposes of computation of its Appropriations Limit pursuant to Article XIII B of the California Constitution for fiscal year 2001-02; and, be it

FURTHER RESOLVED, That the net appropriations limit for fiscal year 2001-02 is established at \$1,717,059,535.
