WHEREAS, In accordance with the PUC Resolution and pursuant to the terms and conditions of the Agreement For Sale of Real Estate, copies of which are on file with the Clerk of the Board of Supervisors in File No. <u>052047</u>, the property owner has agreed to a purchase price of \$30,000, which purchase price was determined by an independent appraisal and approved by the Director of Property; and,

WHEREAS, The Director of Planning, by letter dated July 15, 2005, found that the quitclaim of this easement is categorically exempt from environmental review pursuant to CEQA guidelines and is consistent with the City's General Plan and the Eight Priority Policies of City Planning Code Section 101.1, which letter is on file with the Clerk of the Board of

Supervisors in File No. 052047, and which letter is incorporated herein by this reference; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby adopts the findings set forth in the letter of the Director of Planning, dated July 15, 2005, with respect to CEQA, the City's General Plan and the Eight Priority Policies of City Planning Code Section 101.1 for the same reasons as set forth in the July 15, 2005 letter, and hereby incorporates such findings by reference as though fully set forth in this resolution; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby approves the Agreement For Sale of Real Estate ("Agreement") in substantially the form of the Agreement on file with the Clerk of the Board of Supervisors in File No. 052047, and authorizes the Director of Property to take those actions that the Director of Property or the City Attorney deem necessary or advisable to complete the transaction contemplated in the Agreement and effectuate the purpose and intent of this resolution.
