

1 [Grant for Pandemic Influenza Preparedness.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH),**
4 **Communicable Disease Control and Prevention Section to accept and expend**
5 **retroactively a new grant in the amount of \$88,582, from the California Department of**
6 **Health Services (CDHS), to undertake pandemic influenza emergency preparedness**
7 **and response planning and to enter into an agreement for the use of these funds; for**
8 **the period of May 22, 2006 to April 30, 2008.**

10 WHEREAS, DPH, Communicable Disease and Prevention Section has been awarded
11 a new grant from the CDHS in the amount of \$88,582 to support pandemic influenza
12 emergency preparedness and response planning in San Francisco; and,

13 WHEREAS, The objectives of this project include a) development of a pandemic
14 influenza plan consistent with state guidance; b) public health preparedness for an influenza
15 pandemic; c) laboratory surge capacity; d) coordination of health care surge capacity including
16 alternate care sites; e) risk communication coordination; f) surveillance and epidemiological
17 response capability; g) coordination of social distancing and quarantine actions; h) distribution
18 and dispensing of antivirals and vaccines; and,

19 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
20 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
21 Board of Supervisors in File No. 061653; which is hereby declared to be a part of
22 this resolution as if set forth fully herein; and,

23 WHEREAS, the grant does not require an ASO amendment and reimburses the
24 department for an existing Health Program Coordinator II position (Job Class 2591) at 1.00
25 FTE from January 1, 2007 through August 30, 2007; and,

1 WHEREAS, The grant budget includes a provision for indirect costs of \$8,077; now,
2 therefore, be it


3 RESOLVED, That SFDPH, AIDS Office, is hereby authorized to accept and expend
4 retroactively a grant in the amount of \$88,582 from the CDHS; and, be it

5 FURTHER RESOLVED, That SFDPH is hereby authorized to retroactively accept and
6 expend the grant funds in accordance with the requirements set forth in the Agreement,
7 pursuant to San Francisco Administrative Code section 10.170-1; and, be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
9 agreement on behalf of the City; and, be it


10 FURTHER RESOLVED, That the Controller is directed to designate all positions
11 funded under this agreement as "G" or grant-funded positions which would terminate when
12 the agreement expires.




