Ordinance granting the San Francisco Public Utilities Commission a waiver of Administrative Code section 6.64 to allow the contract amount of Agreement No. CS-525A with Olivia Chen Consultants to exceed one hundred-fifty percent of the original contract amount.

Be it ordained by the People of the City and County of San Francisco:

Section 1. General Findings:

(a) In early 2001, the California Division of Dams (DSOD) required the San Francisco Public Utilities Commission (SFPUC) to conduct a geotechnical exploration program to determine the safe operating levels for the Calaveras Dam and Reservoir.

(b) In the summer of 2001, the SFPUC contracted with Olivia Chen Consultants via As-Needed Contract No. CS-525A, Specialized Engineering Services, to conduct the geotechnical exploration program for the Calaveras Dam and Reservoir. The scope of work involved complex and comprehensive analyses of the surrounding rock and soil conditions using drilling, barge drilling, soil testing and dam instrumentation.

(c) Olivia Chen Consultants completed all fieldwork in July 2002, and completed its final report in January 2003. Based on the final report, DSOD approved the continued operation of Calaveras Reservoir at a reduced water level.

(d) Section 6.64 of the San Francisco Administrative Code provides in relevant part
that cumulative modifications to an as-needed contract shall not result in a contract sum
exceeding one hundred-fifty percent of the original contract amount.

Page 1 3/20/2008 a:\080141-2.doc (e) The original contract amount for Agreement CS-525A was \$800,000. The modification for Olivia Chen Consultants is in the amount of \$309,692 which, if approved, would bring the total contract amount for Agreement CS-525A to \$1,509,691 \$1,506,200.

(f) SFPUC Resolution No. 02-0166 authorizes the General Manager to (i) request that the Board of Supervisors grant a waiver of Administrative Code section 6.64 to allow Agreement No. CS-525A to be increased such that cumulative modifications to the Agreement will exceed one hundred-fifty percent of the original contract amount; and (ii) upon receipt of such a waiver, to increase the contract amount for Agreement No. CS-525A by \$309,692 for a total contract amount of \$1,509,691 \$1,506,200.

(g) The SFPUC arranged for an independent audit of all invoices and expenses to confirm that Olivia Chen Consultants performed additional services in the amount of \$309,692.

Section 2. Waiver of Section 6.64 of the Administrative Code, As-Needed Contracts:

(a) By this Ordinance, the Board of Supervisors grants the SFPUC a waiver of Administrative Code section 6.64 to allow the contract amount of Agreement No. CS-525A with Olivia Chen Consultants to be increased by \$309,692 for a total contract amount of \$1,509,691\$1.506,200.
