RESOLVED, That the Board of Supervisors hereby authorizes the Director of Planning Department to accept and expend a Jefferson Street Redesign grant up to \$30,000 from the Bay Trail Steering Committee; and

FURTHER RESOLVED, that the Board of Supervisors hereby waive inclusion of indirect costs in the grant budget; and

FURTHER RESOLVED, that the Director of the Planning Department is hereby authorized and empowered to execute, deliver and perform, in the name of the City and County of San Francisco, all applications, contracts, agreements, amendments and payment
