3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to**
4 **retroactively accept and expend funds from the Centers for Disease Control &**
5 **Prevention (CDCP) in the amount of \$225,000 to support the STD Surveillance Network;**
6 **for the period of September 30, 2008 through September 29, 2009.**

8 WHEREAS, DPH was awarded a grant from the CDCP for \$225,000 to fund the STD
9 Surveillance Network, for the period of September 1, 2008 through September 29, 2009; and,

10 WHEREAS, The grant is meant for five years, for a total of \$1,125,000, from
11 September 30, 2008 through September 29, 2013, contingent upon successful completion of
12 each year's project goals and objectives; and,

13 WHEREAS, The purpose of the project is to establish and maintain a network of
14 collaborating sites with the capacity to implement a broad range of surveillance activities, the
15 flexibility to rapidly modify the activity over time as trends dictate and the ability to use
16 surveillance data to guide programmatic action; and,

17 WHEREAS, The grant does not require an ASO amendment and reimburses DPH for
18 five existing positions, including an Epidemiologist II (Job Class #2803) at .56 FTE, a
19 Epidemiologist I (Job Class #2802) at .20 FTE, an IS Operator (Job Class #1002) at .25 FTE,
20 a Chief Microbiologist (Job Class #2466) at .20 FTE, and a Lab Assistant (Job Class #2416)
21 at .50 FTE; and,

22 WHEREAS, The grant budget includes a provision for indirect costs in the amount of
23 \$1,740; now, therefore, be it

24 **RESOLVED**, That DPH is hereby authorized to retroactively accept and expend a grant
25 in the amount of \$225,000 from the CDCP; and, be it
