WHEREAS, DPH was awarded a grant from CalTrans for \$500,000 to fund the Safe Routes to School project, for the period of September 1, 2008 through August 31, 2010; and,

WHEREAS, The goal is to increase walking and biking to and from school in San Francisco by coordinating services with local agencies including SF Unified School District, the Municipal Transportation Agency, the Police Department, the Department of Children, Youth and their Families, and the Bicycle Coalition, with DPH as the lead organization; and,

WHEREAS, The grant budget includes a provision for indirect costs in the amount of \$20,857; and,

WHEREAS, Educational services will be managed through a consultant as yet to be determined under contract with DPH for \$135,541; and,

WHEREAS, DPH is eligible to receive Federal and/or State funding for certain Non-Infrastructure Transportation Projects through CalTrans; and,

WHEREAS, Master Agreements, Program Supplemental Agreements, Fund Exchange Agreements, and/or Fund Transfer Agreements need to be executed with CalTrans before such funds could be claimed; and,

FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as a "G" or grant-funded position which would terminate when the agreement expires.
