3 **Resolution re-establishing the Presidio Neighborhood Representative Work Group to**
4 **be comprised of representatives from affected neighborhoods and City Departments.**

6 WHEREAS, The Presidio Trust has begun the process of changing the Presidio Trust
7 Management Plan (PTMP), last adopted in May of 2002; and,

8 WHEREAS, The Presidio Trust is anticipated to release the draft Supplemental
9 Environmental Impact Statement (SEIS) containing an analysis of the environmental impacts
10 of developments proposed at the Presidio in early June 2008; and,

11 WHEREAS, The City and members of the public will be given an anticipated 45 day
12 period to comment on the changes to the Presidio Trust Management Plan and draft
13 Supplemental Environmental Impact Statement; and,

14 WHEREAS, The development in the Presidio could have a tremendous impact upon
15 the City's infrastructure and the demand for City services; and,

16 WHEREAS, The development of the Presidio could have a tremendous impact upon
17 the neighborhoods surrounding the Presidio, especially with regard to traffic, transit,
18 congestion, parking and the impacts directly outside all of the Presidio gates; and,

19 WHEREAS, The Presidio and Golden Gate National Parks provide benefits to the City
20 and County of San Francisco by protecting and managing the parklands which provide open
21 space for recreation, education, and the enjoyment of wildlife at no cost to residents of the
22 City and their visitors; and, now, therefore, be it

23 RESOLVED, That the Board of Supervisors does hereby re-establish the Presidio
24 Neighborhood Representative Work Group, which shall be subject to the mandates of the
25

1 Sunshine Ordinance to review the Supplemental Environmental Environmental Impact
2 Statement and the revisions to the Presidio Trust Management Plan; and, be it

3 FURTHER RESOLVED, That the Presidio Neighborhood Representative Work Group
4 shall include the following representatives and alternate representatives designated by the
5 following groups

6 - one representative from the Neighborhood Associations for Presidio Planning (NAPP)
7 selected by NAPP,

8 -one representative of the Cow Hollow Association selected by Cow Hollow
9 Association,

10 -one representative of the Marina Community Association selected by the Marina
11 Community Association,

12 -one representative of the Marina-Cow Hollow Neighbors and Merchants to be
13 selected by the Marina-Cow Hollow Neighbors and Merchants,

14 -one representative of the Pacific Heights Residents Association selected by the
15 Pacific Heights Residents Association,

16 -one representative of the Planning Association for the Richmond selected by the
17 Planning Association for the Richmond,

18 -one representative of the Presidio Heights Neighborhood Association selected by the
19 Presidio Heights Neighborhood Association,

20 -one representative of the Lake Street Residents Association selected by the Lake
21 Street Residents Association,

22 -one representative of the Laurel Heights Improvement Association selected by the
23 Laurel Heights Improvement Association,

24 -one representative of the Sea Cliff Properties Association selected by the Sea Cliff
25 Properties Association.

1 -one representative of the Golden Gate Valley Neighborhood Association selected by
2 the Golden Gate Valley Neighborhood Association,

3 -one representative of the Sierra Club selected by the Sierra Club,

4 -one representative of the Marina Merchants Association selected by the Marina
5 Merchants Association,

6 -one representative of the Presidio Environmental Council selected by the Presidio
7 Environmental Council,

8 -one representative of the San Francisco Architectural Heritage organization selected by the
9 San Francisco Architectural Heritage organization,

10 -one representative of the Jordan Park Improvement Association selected by the Jordan Park
11 Improvement Association,

12 FURTHER RESOLVED, That the Presidio Neighborhood Representative Work Group
13 shall begin meeting immediately in order to develop its comments on the Presidio Trust
14 Management Plan and Supplemental Environmental Impact Statement; and, be it

15 FURTHER RESOLVED, That this Work Group shall develop a report on the planning
16 actions by the Presidio Trust; and, be it

17 FURTHER RESOLVED, That this Work Group shall report any of its findings, concerns
18 or recommendations to the Board of Supervisors City Operations and Neighborhood Services
19 Committee; and be it

20 FURTHER RESOLVED, The Office of the City Administrator and other relevant City
21 agencies, including the Public Utilities Commission, the Municipal Transportation Authority,
22 Department of Public Works, Transportation Authority, Planning Department, Controller, City
23 Attorney, Mayor's Office of Neighborhood Services, and the Mayor's Office of Economic and
24 Workforce Development, but not limited thereto, shall provide assistance the work group; and
25 be it

1 FURTHER RESOLVED, That the Planning Department, with assistance from the City
2 Attorney, shall provide comments on the Supplemental Environmental Impact Statement and
3 Presidio Trust Management Plan, which shall be provided to the Board of Supervisors City
4 Operations and Neighborhood Services Committee and to the Presidio Trust Board of
5 Directors and the Presidio Trust NEPA Compliance Officer.


