ENDORSING THE CENSUS COMPLETE COUNT COMMITTEE'S WORK IN DEVELOPING
AND COORDINATING A STRATEGIC PLAN IN ALL SAN FRANCISCANS IN THE 2000
CENSUS.

WHEREAS, The decennial census conducted by the U.S. Bureau of Census is mandated by the U.S. Constitution for the purpose of political reapportionment and the next count will be taken on April 1, 2000; and,

WHEREAS, The U.S. Congress has enacted federal laws and programs that rely on an accurate population count and socioeconomic information to allocate federal funds for numerous education, transportation, social service, and other programs; and,

WHEREAS, The City and County of San Francisco relies on census data for planning decisions and allocating government funds; and,

WHEREAS, The 1990 Census failed to count over 837,000 people in California, resulting in the loss of at least one Congressional seat and over a hundred million dollars in federal funding; and,

WHEREAS, The 1990 Census missed almost 22,000 San Francisco residents, about 3% of the City's population; and,

WHEREAS, The undercount in the 1990 Census resulted in San Francisco receiving significantly less federal funding for a wide range of programs that benefit San Francisco residents; and,

WHEREAS, The number of San Francisco children missed in the 1990 census would fill nine additional public schools; and,

WHEREAS, San Francisco has large populations that have been historically undercounted by the Bureau; and,

WHEREAS, Women, children, the poor, the homeless, the elderly, and especially recent immigrants have been historically undercounted; and,

WHEREAS, Experience from other jurisdictions has demonstrated that reducing the undercount requires a coordinated effort by local government agencies, community agencies, community-based organizations, and the media; and,

WHEREAS, A San Francisco Census 2000 Complete Count Committee was convened by Mayor Brown and Supervisor Teng consisting of all City agencies including The City Administrator's Office, the Mayor's Office of Community Development (MOCD), the Department of Children, Youth and their Families (DCYF), the Department of Human Services (DHS), the Department of Public Health (DPH), the Mayor's Budget Office, the Department of Building Inspection (DBI), the Mayor's Office of Housing (MOH), the Mayor's Office of Economic Development (MOED), the Mayor's Office on Homelessness, the Mayor's Office of Criminal Justice (MCJC), the Rent Stabilization Board, the Planning Department, the Housing Authority, and the Immigrant Rights Commission; a CBO consortium that includes Chinese for Affirmative Action (CAA), NAACP, and the Mexican American Legal Defense and Education Fund, the Asian Law Caucus, the Southeast Asian Community Center, NICOS Chinese Health Coalition, Self-Help for the Elderly, Jewish Family and Children's Services, and La Raza Centro Legal; and

members of the media including the World Journal, the San Francisco Chronicle, Sing Tao Daily, the China Press, KTSF, and Channel 66; and

WHEREAS, The San Francisco Census 2000 Complete Count Committee is conducting broad outreach to all communities to ensure a diverse and inclusive group to join and participate in the effort to count all San Franciscans in the 2000 Census; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco endorses the census Complete Count Committee's work in developing and coordinating a strategic plan in addressing the City and County of San Francisco's undercount for the 2000 Census.
