3 **Resolution authorizing the Municipal Transportation Agency to Accept and Expend**
4 **\$1,123,364 of Transportation Fund for Clean Air Regional Funds for the three Capital**
5 **Improvement Projects: the Transit Bus Traffic Signal Prioritization; Transit Bus**
6 **Replacement: 15 CNG or Hybrid Electric Vehicles; and Bicycle Racks - Installation of**
7 **Bicycle Racks on 50 Vehicles.**

8 WHEREAS, The Bay Area Air Quality Management District (BAAQMD) is authorized to
9 make Transportation Fund for Clean Air (TFCA) Regional Funds available pursuant to TFCA
10 Regional Fund guidelines; and

11 WHEREAS, The San Francisco Municipal Transportation Agency (MTA) is an eligible
12 applicant for TFCA Regional Funds; and

13 WHEREAS, BAAQMD has conducted a Call for Projects and has approved awarding
14 \$1,123,364 in Transportation Fund for Clean Air (Regional Funds) to the Municipal
15 Transportation Agency to partially implement the following clean air vehicle projects:

- 16 1) Transit Bus Traffic Signal Prioritization (\$150,000)
17 2) Transit Bus Replacement: 15 CNG or Hybrid Electric Vehicles (\$910,000)
18 3) Bicycle Racks: Installation of Bicycle Racks on 50 Vehicles (\$63,364); and

19 WHEREAS, BAAQMD requires that the City enter into funding agreements in order to
20 receive the funds to be used for these projects; and

21 WHEREAS, The Municipal Transportation Agency proposes to maximize use of
22 available grant funds on program expenditures by not including indirect costs in the grant
23 budget; now, therefore, be it

1 RESOLVED, That the Board of Supervisors authorizes the Municipal Transportation
2 Agency to accept and expend \$1,123,364 from the Bay Area Air Quality Management
3 District's Transportation Fund for Clean Air (TFCA) Regional Funds for the following projects:

Transit Bus Replacement – 15 CNG or Hybrid Electric Vehicles	910,000
Bicycle Racks on Buses – Installation of Bicycle Racks on 50 Vehicles	63,364


