10 **adding Section 781.10 to create the 17<sup>th</sup> and Rhode Island Grocery Store Special Use**  
11 **Subdistrict.**

13 WHEREAS, On December 16, 2002, Supervisor Maxwell introduced legislation to  
14 amend the Zoning Map of the City and County of San Francisco by amending Section Maps 8  
15 and 8SU for the property described as Assessor's Block 3978, Lot 1 (bounded by Rhode  
16 Island Street, 17th Street, Kansas Street and Mariposa Street) from M-1 (Light Industrial) to  
17 NC-3 (Moderate-Scale Neighborhood Commercial District) and the 17th Street and Rhode  
18 Island Grocery Store Special Use Subdistrict; and

19 WHEREAS, On December 16, 2002, Supervisor Maxwell introduced companion  
20 legislation to amend the Planning Code by adding Section 781.10 to create the 17th and  
21 Rhode Island Grocery Store Special Use Subdistrict; and,

22 WHEREAS, On December 30, 2002, the Clerk transmitted a copy of both pieces of  
23 legislation to the Planning Commission for public hearing pursuant to Planning Code Section  
24 302(b); and,

WHEREAS, Planning Code Section 306.4(d)(3) provides that the Planning Commission must render a decision on the proposed legislation within 90 days of the date of referral and that failure to act within the prescribed time shall constitute disapproval; and,

WHEREAS, Planning Code Section 306.4(d)(3) authorizes the Board of Supervisors to extend by resolution the prescribed time within which the Commission is to render its decision on legislation initiated by the Board; and,

WHEREAS, The Planning Commission needs an extension of time in order to complete environmental review and hold a hearing on the proposed legislation; and,

WHEREAS, The Board deems it appropriate in this instance to grant the Planning Commission an additional 90 days within which to render its decision; now, therefore, be it

RESOLVED, That the Board hereby extends the prescribed period of time within which the Planning Commission must review and render its decision on the proposed legislation for an additional 90 days from March 30, 2003.




