AUTHORIZING THE SAN FRANCISCO PUBLIC LIBRARY TO <sup>retroactively</sup> ACCEPT AND EXPEND A TOTAL  
\$481,000  
OF ~~\$923,493~~ FROM THE CALIFORNIA STATE LIBRARY, PUBLIC LIBRARY FOUNDATION  
PROGRAM AUGMENTING THE FY98/99 BUDGET WITH A SUPPLEMENTAL APPROPRIATION  
OF \$481,000.

WHEREAS, The Public Library Foundation Program of the California State Library distributes  
funding to certified public libraries based on a per capita formula, and

WHEREAS, San Francisco Public Library has been certified to receive such funds, and

WHEREAS, The State Legislature augmented the Public Library Fund by \$20 million for the  
FY98/99 funding cycle, and

WHEREAS, Prior to the augmentation, the San Francisco Public Library estimated it would  
receive \$442,000 which was appropriated for FY98/99, and

WHEREAS, San Francisco Public Library will receive an additional \$481,000 for a total  
distribution of \$923,000, and

WHEREAS, The San Francisco Public Library has a need for additional funds, and


WHEREAS, based on the revised State mandated per capita formula and the current population  
of The City and County of San Francisco, the San Francisco Public Library is certified to receive the  
additional monies, now therefore be it

RESOLVED, that the San Francisco Public Library, be authorized to <sup>retroactively</sup> accept and expend  
\$481,000  
~~-\$923,000~~ from the California State Library Public Library Fund which includes the supplemental amount  
of \$481,000.




