AUTHORIZING THE RECREATION AND PARK DEPARTMENT TO APPLY, ACCEPT AND EXPEND A \$1,970,000 GRANT FOR THE RESTORATION OF THE CONSERVATORY OF FLOWERS, GOLDEN GATE PARK; A \$492,500 GRANT FOR CONSTRUCTION OF KING POOL; AND A \$197,000 GRANT FOR LAKE MERCED HABITAT RESTORATION, ALL RECEIVED FROM THE STATE OF CALIFORNIA GENERAL FUND DURING FISCAL YEAR 1998-99.

- Approves the application, acceptance and expenditure of \$1,970,000 for restoration of the 1. Conservatory of Flowers, Golden Gate Park, including preparation of construction documents; \$492,500 for the construction of King Pool; and \$197,000 for Lake Merced habitat restoration;
- Certifies that the City and County of San Francisco Recreation and Park Department is in 2. accordance with the general provisions of the agreement with the State of California;
- Certifies that the City and County of San Francisco has sufficient funds to operate and maintain 3. the projects funded under this program;
