3 **Resolution authorizing the Department of Public Health to retroactively accept a**
4 **gift from the San Francisco General Hospital Foundation with a monetary value of**
5 **\$104,538 to back fill-staff attending training designed to decrease the risk of**
6 **cardiovascular events (heart attacks and strokes) for the period of January 1,**
7 **2008 though December 31, 2010**

10 WHEREAS, studies have shown that ischemic heart disease is the leading cause
11 of premature death amount both men and women; and

12
13 WHEREAS, cerebrovascular disease (stroke) is the second leading cause of
14 premature death among women and the fourth leading cause among men; and

15
16 WHEREAS, Kaiser Permanente Northern California Region, Community
17 Benefit Program, Prevent Heart Attacks and Strokes Everyday (PHASE) Initiative 2007
18 will provide \$399,837 to the San Francisco General Hospital Foundation for the period
19 of January 1, 2008 through December 31, 2010 fund development of programs within
20 the San Francisco Safety Net to decrease risk of cardiovascular events (hearts and
21 strokes); and

23 WHEREAS, Safety Net care in San Francisco is provided by the San Francisco
24 Department of Public Health (DPH) in cooperation with the San Francisco Community
25 Clinic Consortium (SFCCC); and

1 WHEREAS, DPH and SFCCC have been involved in collaborative projects to
2 strengthen programs targeted at the City's most vulnerable populations; and
3

4 WHEREAS, the UCSF Department of Family and Community Medicine will
5 create pilot trainings to develop interventions to improve clinician prescribing practices
6 and abilities to promote healthy lifestyle and medication adherence among patients; and
7

8 WHEREAS, the trainings will be held at four DPH Primary Care clinics in year
9 one and an additional two clinics in year two; and
10

11 WHEREAS, while DPH clinical staff are attending the training their positions will
12 be back-filled by other staff or by overtime; and
13


14 WHEREAS, the San Francisco General Hospital Foundation will provide
15 \$104,538 to DPH to cover the cost of back-filling the clinical staff while they attend the
16 training; and

18 WHEREAS, DPH wishes to obtain approval from the Health Commission and the
19 Board of Supervisors to accept the donation from the San Francisco General Hospital
20 Foundation; and now, therefore; be it
21

22 RESOLVED, that the Department of Public Health, is hereby authorized to
23 accept this gift in accordance with the requirements set forth pursuant to San Francisco
24 Administrative Code Sections 10.100-305 and 10.100-201; and, be it

2 FURTHER RESOLVED, that the Department of Public Health is hereby
3 authorized to retroactively accept a gift of \$104,538 from the San Francisco Foundation
4 to cover the cost of back-filling clinical while they attend PHASE trainings designed to
5 decrease the risk of cardiovascular event within the San Francisco Health Safety Net for
6 the period of January 1, 2008 through December 31, 2010




