Resolution authorizing the Airport Commission to accept and expend two (2) grants totaling \$298,000 from the Bay Area Air Quality Management District (Air District) for acquisition of clean air vehicles by Airport transportation operators.

WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle emissions in the region and on terminal roadways; and

WHEREAS, The Air District assists public agencies in implementing emissions reduction projects, such as the addition of clean air vehicles to fleets; and,

WHEREAS, The Airport Commission in Resolutions 06-0026 and 06-0203 approved seeking, accepting, and expending Air District funds for clean air vehicles; and

WHEREAS, Grant 06VIP28 provides \$100,000 for 25 natural gas-powered taxis and vans, and Grant 06R32 provides \$198,000 for 14 natural gas-powered hotel, parking, and airline crew minibuses; and

WHEREAS, The Airport would administer this grant, disburse incentive funds to airport transportation operators, and provide the Air District with information concerning the new vehicles; and

WHEREAS, The grant does not require ASO amendment; and,

WHEREAS, No Airport or City funds would be used for this program; and

WHEREAS, This demonstration project would continue the Airport's leadership role in promoting clean fuel use among transportation providers; and

WHEREAS, The Airport proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That, pursuant to San Francisco Administrative Code §10.171, the Board of Supervisors does hereby authorize the Airport Commission to accept and expend funds awarded in this grant; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.
