

1 [Approving Amendment to Paratransit Broker Agreement with ATM/Vancom.]

3 **Resolution approving Amendment No. 7 to Agreement between the City and County of**  
4 **San Francisco and ATC/Vancom, Inc., to extend the current contract for two years,**  
5 **through March 31, 2010; to augment the scope of work to implement the new debit card**  
6 **program; to lease up to 40 new vans to the Paratransit Broker for use in the Paratransit**  
7 **Program; and to increase the contract amount by \$33,803,476, for a total contract**  
8 **amount not to exceed \$191,825,015.**

10 WHEREAS, On January 4, 2000, the Public Transportation Commission adopted  
11 Resolution No. 00-003, which approved the Agreement Between the City and County of San  
12 Francisco and Comsis Mobility Services, Inc., dba Intelitran ("Paratransit Broker Agreement"),  
13 to administer the City's Paratransit Program, which Agreement was approved by the Board of  
14 Supervisors under Resolution No. 104-00, dated February 18, 2000; and

15 WHEREAS, The Paratransit Broker Agreement commenced on April 1, 2000, for a  
16 term of five years; and,

17 WHEREAS, On April 1, 2001, the Director of Transportation approved Amendment No.  
18 1 to the Paratransit Broker Agreement, which incorporated an Incentive/Disincentive Program  
19 into the Agreement; and,

20 WHEREAS, On December 18, 2001, the Municipal Transportation Agency Board of  
21 Directors ("SFMTA Board") adopted Resolution No. 01-126, which approved Amendment No.  
22 2 to the Paratransit Broker Agreement, for the sublease of 24 ramped minivans to paratransit  
23 taxi service providers, which Amendment was approved by the Board of Supervisors under  
24 Resolution No. 70-02, dated January 28, 2002; and,

1 WHEREAS, On August 11, 2003, the SFMTA Board approved an Assignment and  
2 Assumption Agreement, under which the Paratransit Broker Agreement was assigned from  
3 COMSIS to ATC/Vancom, Inc., doing business in California as ATC/Van der Aa Group, Inc.;  
4 and,

5 WHEREAS, ATC is now owned by Veolia Transportation Services, Inc.; and

6 WHEREAS, On October 7, 2003, the SFMTA Board adopted Resolution No. 03-164,  
7 which approved Amendment No. 3 to the Paratransit Broker Agreement, increasing the  
8 contract amount to a sum not to exceed \$92,641,933; and

9 WHEREAS, On December 09, 2003, the Board of Supervisors adopted Resolution No.  
10 776-03, which approved Amendment No. 3, but only for an amount not to exceed \$77,333,277  
11 – an amount sufficient to meet the increased demand for and cost of paratransit service  
12 through June 30, 2004; and

13 WHEREAS, On July 22, 2004, the Board of Supervisors adopted Resolution No. 430-  
14 04, which approved Amendment No. 3A to the Paratransit Broker Agreement, to increase the  
15 contract amount by \$15,308,656 for a total contract amount not to exceed \$92,641,933, to  
16 meet the increased demand for and costs of paratransit service through the remainder of the  
17 term of the Agreement; and

18 WHEREAS, On November 2, 2004, the SFMTA Board adopted Resolution No. 04-160,  
19 which approved Amendment No. 4 to the Paratransit Broker Agreement, to extend the  
20 contract period for three years, through March 31, 2008, and to increase the total amount of  
21 the contract by \$65,379,606, for a total contract amount not to exceed \$158,021,539, which  
22 amendment was approved by the Board of Supervisors under Resolution No. 770-04, dated  
23 December 14, 2004; and,

24 WHEREAS, On October 19, 2005, the City, through the Director of Transportation, and  
25 Contractor executed Amendment No. 5 to Agreement, in which the City agreed to require a

1 successor paratransit broker to assume the unexpired portion of a lease of office space for the  
2 broker to administer the Paratransit Program; and

3 WHEREAS, On November 15, 2005, the SFMTA Board adopted Resolution No. 05-  
4 171, which authorized the execution of Amendment No. 6 to the Paratransit Broker  
5 Agreement, for the City to lease accessible vans to Contractor, for sublease to Lift Van/ADA  
6 Access providers participating in the Paratransit Program, and requiring the Contractor to  
7 institute a vehicle inspection program to ensure that regular maintenance is taking place and  
8 is clearly documented, which amendment was approved by the Board of Supervisors on  
9 February 3, 2006 under Resolution No. 40-06; and

10 WHEREAS, The SFMTA has negotiated Amendment No. 7 to the Paratransit Broker  
11 Agreement, which provides a two-year extension of the Agreement, which is set to expire on  
12 March 31, 2008, to allow for the smooth implementation of the paratransit debit card project;  
13 and

14 WHEREAS, The Amendment also includes additional tasks related to the debit card  
15 project and a provision to lease up to 40 new paratransit vans to the Broker for use in the  
16 Paratransit Program; and

17 WHEREAS, On January 15, 2008, the SFMTA Board of Directors approved Resolution  
18 No. 08-011, which authorized the Executive Director/CEO to execute Amendment No. 7 to the  
19 Paratransit Broker Agreement with ATC, to extend the Agreement for two years, through  
20 March 31, 2010, with an increase to the contract amount of \$33,803,476, for a total contract  
21 amount not to exceed \$191,825,015; now, therefore, be it

22 RESOLVED, That the Board of Supervisors approves Amendment No. 7 to the  
23 Agreement between the City and ATC/Vancom, to extend the current contract for two years,  
24 through March 31, 2010; to augment the scope of work to implement the new debit card  
25 program; to lease up to 40 new vans to the Paratransit Broker for use in the Paratransit

1 Program; and to increase the contract amount by \$33,803,476, for a total contract amount not  
2 to exceed \$191,825,01.
