WHEREAS, the Juvenile Probation Department is the recipient of a gift of \$ 12,758.05 from Florine Friedlander, an individual, deceased; and,

WHEREAS, this gift is to be used solely for the direct benefit of at-risk youth under the jurisdiction of the Juvenile Probation Department, and;

WHEREAS, the Volunteer Auxiliary of the Youth Guidance Center provides services that seek to generate a sense of self-worth and dignity for youth under the jurisdiction of the Juvenile Probation Department, and;

WHEREAS, the Chief Probation Officer wishes to allocate said gift to the Volunteer Auxiliary of the Youth Guidance Center for the direct benefit of youth under the Department's jurisdiction.

WHEREAS, the Juvenile Probation Commission concurs with the wishes of the Juvenile Probation, Chief Probation Officer as a prudent use of said funds, and;

WHEREAS, the Board of Supervisors authorized the Chief Probation Officer to enter into an agreement with Golden Gate Genealogy by adopting Resolution No. 1157-97, and;

WHEREAS, said agreement in consideration of Golden Gate Genealogy's efforts in locating this gift and notifying the Juvenile Probation Department of these assets and procuring proof of entitlement, provides that Golden Gate Genealogy be paid ten-percent (10%) of any interest the Juvenile Probation Department has in said assets;

WHEREAS, the Juvenile Probation Department wishes to disburse the \$12,758.05 gift as follows: The Volunteer Auxiliary of the Youth Guidance Center is to receive eleven thousand four hundred eighty-two dollars and twenty-five cents, \$11,482.25 and Golden Gate Genealogy is to receive ten percent or one thousand two hundred seventy-five dollars and eighty cents, \$1,275.80, the total of said allocations equaling the total gift of twelve thousand seven hundred fifty-eight dollars and five cents, \$12,758.05, therefore be it;

RESOLVED, that the Board of Supervisors authorizes the Chief Probation Officer for the Juvenile Probation Department to accept and expend a gift from Ms. Florene Friedlander for the benefit of at-risk youth under the jurisdiction of the Juvenile Probation Department; and be it

FURTHER RESOLVED, the Board of Supervisors authorizes the Chief Probation Officer for the Juvenile Probation Department to pay The Volunteer Auxiliary of the Youth Guidance Center, eleven thousand four hundred eighty-two dollars and twenty five cents, \$11,482.25 and to pay Golden Gate Genealogy, one thousand two hundred seventy-five dollars and eighty cents, \$1,275.80, equaling the total gift of twelve thousand seven hundred fifty-eight dollars and five cents, \$12,758.05.
