2 AMENDING RESOLUTION NOS. 667-90 AND 955-93 TO ADD THE NEIGHBORHOOD PARKS  
3 COUNCIL AS AN ORGANIZATION QUALIFIED TO SUBMIT NOMINATIONS FOR  
4 APPOINTMENT TO THE PARK AND OPEN SPACE ADVISORY COMMITTEE PURSUANT TO  
5 CHARTER SECTION 16.107(G).

6 WHEREAS, Charter Section 16.107 establishing the Park and Open Space Program contains  
7 provisions which require the Board of Supervisors to make certain appointments to its advisory  
8 committee from an approved list of individuals representing citizens' organizations which have as a  
9 major goal the enhancement and preservation of San Francisco's parks , open space and natural  
10 environment; and,

11 WHEREAS, The Board of Supervisors adopted Resolution No. 667-90 approving the list of  
12 qualifying organizations on August 13, 1990, as amended by Resolution 955-93 adopted by the Board  
13 of Supervisors on November 22, 1993 and later amended by Resolution 837-98 adopted by the Board  
14 on October 13, 1998; and,

15 WHEREAS, The below designated organization has petitioned the Board of Supervisors to be  
16 added to the list and meets the aforementioned criteria; now, therefore, be it,

17 RESOLVED, That the Board of Supervisors of the City and County of San Francisco does  
18 hereby add to Resolution No. 667-90, as amended by Resolution 955-93 by identifying the hereinafter  
19 designated organization as qualified to submit nominations for appointment to the Park and Open Space  
20 Advisory Committee, pursuant to the provisions of the San Francisco Administrative Code, Section  
21 5.90, and the San Francisco Charter Section 16.107: Neighborhood Parks Council.




